# SCCL posts record Rs 32,830 cr sales

Registers growth of 23% over the turnover of Rs 26,619 crore achieved in 2021-22

The Singareni Collieries Company Limited (SCCL) posted a record turnover of Rs 32,830 crore during the financial year 2022-23 by registering considerable growth in coal production.

According to a statement on Monday, the company registered a growth of 23 per cent over the turnover of Rs 26,619 crore achieved in the previous financial year (2021-22). Of the total turnover, Rs 28,459 crore came through the sale of coal and Rs 4,371 crore by way of the sale of power through the Singareni Thermal Power Station.

Chairman and managing director of the company N Sridhar said the company

registered a growth of 25 per cent in the sale of coal and 13 per cent in the sale of power during the 2021-22 fiscal. "Efforts will be made to reach a turnover of Rs 50,000 crore in the next three years," he said, adding that the company had set a target to increase the annual coal production to 75 million tonnes during the 2023-34 fiscal and 80 million tonnes by 2025.

Later, during a review meeting, Sridhar said the production of 104 lakh tonnes of coal from the Naini open cast mine in Odisha, VK open cast mine in Kothagudem, JK OC expansion mine in Yellandu area and Goleti OC, would play a vital role in achieving the coal production target of the company in the coming

He said that all permissions have been obtained for the Naini coal block and if the Odisha government operates, the company could produce 60 lakh tonnes of coal during the

2023-24 fiscal, 100 lakh tonnes next year and 150 lakh tonnes per year thereafter. With almost all the permits obtained for the VK open cast in Kothagudem and forest permits coming soon, at least 30 lakh tonnes

of coal production should be achieved annually, he said, adding that the JK OC expansion mine in Yellandu area was expected to produce at least 10 lakh tonnes of coal by the end of this year. Stating that the State-

owned coal companies would be facing tough competition from private players in coming years, Sridhar directed officials to take steps to bring down production costs of coal extraction as it would help the com-

pany in competing in the market. The SCCL achieved the highest-ever annual production of 671 lakh tonnes of coal during the financial year 2022-23. This is 3.25 per cent higher than the production of 650 tonnes achieved in 2021-22.

The company transported about 667 lakh tonnes of coal during the current fiscal, which is two per cent more than the previous year. Besides Telangana, the company has supplied coal to thermal power stations in eight States and to about 2,000 industries across the country. On March 31, Singareni also surpassed the record of 2.59 lakh tonnes achieved on March 11, 2016, by transporting 2.64 lakh tonnes of coal, the highest in its history.

## ‘Mana Nagaram’ to resume in Hyd

### MA&UD Minister urges builders to utilise C&D plants

Telangana's 'Mana Nagaram' programme (Town Hall meeting), aimed at addressing the grievances of citizens by getting the administration closer to their doorsteps, will be resumed in the city soon.

MA&UD Minister KT Rama Rao said the cool roof programme would be one of the important agenda to be discussed during the meetings, he said.

The Minister specifically wanted the builders to utilise the Construction and Demolition (C&D) plants set up at Fathullaguda and Jeedimetla. These C&D plants were not being utilised to full capacity and at many construction sites, the waste was being dumped on the roadsides.

Just make one phone call, all the debris would be lifted from the sites and transported to the plants, he said to the builders. "In addition to these two plants, four more plants are being set

up. They are being established to keep the city clean and ensure effective recycling of the waste," he said, adding that possibilities should be explored to use tiles made out of C&D waste for the cool roof programme by adding some additional components.

#### CPR training

The Minister directed the GHMC to conduct Cardiopulmonary resuscitation (CPR) training pro-

grammes extensively involving Resident Welfare Associations. "There is a need to sensitise RWAs on CPR. GHMC officials should go to each apartment and train the residents on CPR. Unless the sense of community participation was not ensured, it would not be successful," he said. He further said that the real estate sector was booming in Hyderabad since the last nine years due to transparent govern-

ance, implementation of TS-bPASS and other programmes. In 2014, when enquired with builders as to why high-rise structures and aesthetically elevated buildings were not constructed in Hyderabad, they replied that there was no appetite for such structures in Hyderabad, he recalled.

"I had asked builders to be patient for one year and assured them that Hyderabad will start rocking by 2015. It came true," he said. In 2022, Hyderabad ranked first in terms of highest office space absorption by beating Bengaluru, Pune, Chennai and Mumbai. Last year, when 4.50 lakh jobs were created in the IT sector in the country, 1.50 lakh jobs were generated in Hyderabad and 1.46 lakh in Bengaluru, he said. "This is just the beginning and our journey has started now. Our future is going to be bright," he said, adding that no other city or State could claim anything like Hyderabad's infrastructure.
