**REVISED NOTIFICATION No.02/2026,Dt.10.07.2026**

TELANGANA STATE SOUTHERN POWER DISTRIBUTION COMPANY LIMITED (TGSPDCL) was incorporated under the Companies Act 1956 as wholly owned State Government Company. The Company with Head quarters at Hyderabad is carrying out electricity distribution business and is catering the electricity requirements of 15 districts in Telangana State Viz:- Mahabubnagar, Wanaparthi, Nagarkurnool, Jogulamba-Gadwal, Narayanpet, Nalgonda, Bhongir-Yadadri, Suryapet, Medak, Siddipet, Sangareddy, Vikarabad, Rangareddy, Medchal-Malkajgiri and Hyderabad Districts.

Notifications was issued on 17.04.2026 inviting applications for the posts of Chairperson, Consumer Grievances Redressal Forum-I (Rural) and Chairperson, Consumer Grievances Redressal Forum-II (GHMC) in terms of the then applicable regulations.

Subsequently, the Hon'ble Telangana Electricity Regulatory Commission (TGERC) issued a Public Notice dated 05.05.2026 proposing the Draft Telangana Electricity Regulatory Commission (Establishment of Mechanism for Redressal of Grievances of Consumers) Regulation, 2026. In view of the said draft regulation and the subsequent directions of the Hon'ble Commission, the notifications issued earlier were kept in abeyance.

The Hon'ble Telangana Electricity Regulatory Commission has now notified Regulation No. 06 of 2026, namely the Telangana Electricity Regulatory Commission (Establishment of Mechanism for Redressal of Grievances of Consumers) Regulation, 2026, repealing Regulation No. 3 of 2015. The newly notified Regulation contains significant changes in the provisions governing the constitution of Consumer Grievances Redressal Forums, including the eligibility criteria, terms and conditions, and procedure for appointment of the Chairperson.

Accordingly, this Revised Notification is hereby issued inviting applications from eligible candidates, in the prescribed proforma, for appointment to the posts of:

- 1. Chairperson, Consumer Grievances Redressal Forum-I (Rural)**
- 2. Chairperson, Consumer Grievances Redressal Forum-II (GHMC)**

In the Southern Power Distribution Company of Telangana Limited (TGSPDCL), in accordance with the provisions of Regulation No. 06 of 2026 and other applicable orders/instructions issued by the Hon'ble Telangana Electricity Regulatory Commission from time to time.

Eligible candidates fulfilling the prescribed qualifications and other conditions may submit their applications in the prescribed format within the stipulated time.

The area of jurisdiction of each CGRF in TGSPDCL is as follows:

**CGRF-I (Rural):** Mahabubnagar, Wanaparthy, Nagarkurnool, Jogulamba-Gadwal, Narayanpet, Nalgonda, Bhongir-Yadadri, Suryapet, Medak, Siddipet and Sangareddy Districts. (Containing 11 TGSPDCL Operation Circles)

**CGRF-II (GHMC):** Hyderabad, Rangareddy, Medchal-Malkajgiri and Vikarabad Districts. (Containing 10 TGSPDCL Operation Circles)

The desirous eligible Candidates may submit the application in prescribed format well in advance not later than **05-08-2026 by 5.00 pm**, addressed to the Chairman & Managing Director, TGSPDCL, Corporate Office, 6-1-50, Mint Compound, Hyderabad – 500 063, Telangana, India.

### **I. Eligibility:**

**1. Age:** The applicants should have attained a minimum age of fifty-five (55) years and shall have not attained the maximum age of (63) years as on the date of notification of the vacancies.

### **2. Eligibility Criteria:**

The applicant shall be:-

- (i) a retired District Judge or a retired judicial Officer having served for 20 years of service in the State of Telangana;  
or
- (ii) a retired Chief Engineer(Electrical)/Chief General Manager (Electrical) of a Distribution/Transmission licensee having 20 years of experience in the State of Telangana;  
or
- (iii) a retired Chief General Manager(Accounts Services) from a distribution licensee having 20 years of experience in the State of Telangana.

Serving officers holding any of the above-mentioned positions are also eligible to apply

Provided that the officers holding /retired from the post of Chief Engineer Electrical)/ Chief General Manager Electrical)/ Chief General Manager Accounts Services) on 'In-charge' basis, possessing the prescribed experience, shall also be eligible to apply",

Provided further that such of the officers shall not be holding any of the positions as on the date of joining.

### **3. Tenure:**

The Chairperson of the Forum shall hold office for a period not exceeding three (3) years or till attaining the age of Sixty Five (65) years, whichever is earlier.

The Chairperson shall not be eligible for any extension of term or for re-appointment. The Chairperson may relinquish their office by giving a prior notice of not less than three(3) months in writing to the appointing authority

### **4. Job profile:**

The Chairperson shall work full-time and the Forum shall conduct at least one sitting in each week in its jurisdiction and all grievances shall be redressed within the time-limit specified in this Regulation. The Forum shall ensure that it considers all grievances especially relating to billing disputes, non-supply, delay in release of new connection/service, disconnection and re-connection, change of category, change of name or address and quality of supply as per Standards of Performance specified by the Commission, even if it receives them through letters, emails or any other electronic form as recognized by the Information Technology Act, 2000 and in-terms of regulation 3 of 2015 and Regulation 6 of 2026. The Chairperson shall discharge his/her duties & responsibilities as stipulated by the Telangana Electricity Regulation Commission from time to time.

### **5. Emoluments:**

- i. Consolidated monthly Remuneration of Rs. 1,20,000/- (Rupees one lakh and twenty thousand only) during the first year of service, Rs.1,35,000/- (Rupees one lakh and thirty-five thousand only) during the second year of service and Rs.1,50,000/- (Rupees one lakh and fifty thousand only) during the third year of service without any deduction on account of pension from such remuneration (They are not entitled for any Dearness Allowance and House Rent Allowance

- ii. **Leave:** He/She will be eligible for Casual Leave and Earned Leave as admissible to the serving temporary Telangana State Govt. Servant. However, he/she will not be permitted for encashment of Earned Leave.
- iii. **TA & DA:** He/she will be eligible for TA & DA on official tours as applicable under rules of Telangana State Govt.
- iv. **LTC:** He/she will not be eligible for Leave Travel concession.
- v. He/she will not be eligible for pension and gratuity for the service rendered in the CGRF.
- vi. He/she will not be eligible for medical reimbursement.
- vii. **Vehicle:** He/she will be provided a vehicle for official use with a limit of 3000 Kms. and a monthly hire rate of not exceeding Rs.41,000/-.
- viii. **Mobile charges:** He/she will be eligible for mobile usage charges on par with the Officers of TGSPDCL.
- ix. One office attendant shall be provided to him/her.

The remuneration and other service conditions shall be subject to such revisions/modifications as may be decided by the Commission from time to time, and the same shall be applicable to the selected candidates.

No other benefits shall be extended after completion of his/her tenure or on his/her termination/relinquishment of the appointment

## **II. SUBMISSION OF APPLICATIONS:**

1. The applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying.
2. The applicants have to submit the application along with enclosures well in advance. Applications received after due date will be rejected. The TGSPDCL will not be responsible for the postal delay.
3. Applicants desiring to apply for both the posts of Chairpersons/CGRF-I & CGRF-II, separate application has to be submitted for each post.
4. Incomplete/in-correct/in-eligible application form will be summarily rejected. TGSPDCL under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling up the application form at the time of submission. If any lapse is detected during the scrutiny, the

candidature will be rejected even though he/she comes through the final stage of recruitment process or even at later stage.

5. The applicants should not furnish any false/tampered/fabricated information or suppress any material information while filling of the application form.

6. Mere submission of application and mere attending of interview does not confer any right on the applicant for appointment to the post of Chairperson/CGRF.

7. **Candidates who have already applied for the above positions pursuant to the notification dated 17.04.2026, and whose applications are found eligible in accordance with the provisions of Regulation No. 06 of 2026, are not required to submit a fresh application. However, applications submitted by candidates who had applied pursuant to the aforesaid notification but are found ineligible under the provisions of Regulation No. 06 of 2026 shall be treated as rejected.**

### **III. CHECK LIST:**

1. Application Form in prescribed proforma in duplicate.
2. Educational Qualification Certificates
3. Evidence of Work experience.

**Note:** Applicants satisfying the eligibility criteria will be shortlisted and shall be called for to attend the interview.

### **IV. Other Instructions:**

No Person shall be appointed and/or be entitled to continue as a Chairperson or a Member if he/she stands disqualified on account of his/her;

- a) Having been adjudged an insolvent;
- b) Having been convicted of an offence which, in the opinion of the Licensee, involves a moral turpitude
- c) Having become physically or mentally incapable of acting as such a member;
- d) Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a Chairperson;
- e) Having so abused his/her position as to render his/her continuance in office prejudicial to public interest;
- f) Having been guilty of proved misbehavior;
- g) Refusal or failure, without reasonable cause to discharge the functions for a period of at least three months; or
- h) Ceases to fulfill any of the conditions of his/her appointment as a Member.

The Southern Power Distribution Company of Telangana State Ltd (TGSPDCL) reserves the right to modify/cancel the Notification and/or Recruitment Process without assigning any reason.
